  5. Submits two letters of recommendation, one from a school instructor and one from a member of the Saginaw Alumnae Chapter of Delta Sigma Theta Sorority Inc.
  6. Provides a written, one page essay on "Why I Want to Be a Del Sprite"
  7. Required to participate in a group public service project after the Ribbon Ceremony leading to the Induction
