B. COMMUNICATIONS:

1. **February 28, 2020:** Spoke with Workshop Facilitators about creating a question and answer sheet to help determine winner for the Etiquette Award.
2. **March 11, 2020:** Discussion with Committee Member Dawn Tatum regarding escort attire/information and idea for Delta Doll gift for the introduction of Cotillion. Discussion with Shalanda Ellison regarding Cotillion Program.
3. **March 13, 2020-** Tea Party Workshop Facilitators, Stella Johnson and Alois Smith agreed to have tea party with new time from 11am to 1:30pm on March 28, 2020 at Bridgeport Public Library.
4. **March 15, 2020:** Spoke with Stacey Rhoden regarding a time to meet to further discuss the opener of the Cotillion. (How to collaborate the two programs together).
5. **March 18, 2020-** Provided Stacey with a diagram per our discussion and meeting of how introduction of the cotillion will flow...**Need to discuss with Program Committee** about the idea and diagram. Both LaNasia C. Hood and Stacey Rhoden agreed with the flow.
