Project Summary

Create a new mobile application to assist in gathering RFQ data. The new application will consist of a standalone Android based application to gather data in the field and a web-based administration area for viewing data.

Mobile App

Mobile Application Design

- Installable on any modern Android device
- Private app (will not be hosted on App Store) will be installable by MPI
- Application will be able to gather RFQ data without needing an internet connection
- RFQ data will be stored on the device and synced back to the main webserver when a connection is available.
- Application will not have any added security and will rely on the security of the Android device
- Data to be gathered is outlined in the RFQ document provided by Kyle Rhodes
 - Kyle is working on revising these before development begins
- Screen layouts will be optimized for a tablet
